RESOLUTION OF BOROUGH OF GLEN RIDGE, IN THE COUNTY OF ESSEX, NEW JERSEY MAKING APPLICATION TO THE LOCAL FINANCE BOARD PURSUANT TO N. J. S. A. 40A:2-51

WHEREAS, The Borough Of Glen Ridge, in The County Of Essex, New Jersey (the "Borough"), desires to make application to the Local Finance Board for its review and approval of a proposed tax appeal refunding bond ordinance authorizing the issuance of tax appeal refunding bonds or notes to finance amounts owed to others for the payment of taxes in accordance with N.J.S.A. 40A:2-51.

WHEREAS, The Borough believes that:

- (a) it is in the public interest to accomplish such purpose; **and**,
- (b) said purpose or improvements are for the health, welfare, convenience or betterment of the inhabitants of the local unit; **and**,
- (c) the amounts to be expended for said purpose or improvements are not unreasonable or exorbitant; **and**,
- (d) the proposal is an efficient and feasible means of providing services for the needs of the inhabitants of the local unit and will not create an undue financial burden to be placed upon the local unit.

NOW THEREFORE, BE IT RESOLVED BY THE BOROUGH COUNCIL OF THE BOROUGH OF GLEN RIDGE, IN THE COUNTY OF ESSEX, NEW JERSEY, as follows:

Section 1. The application to the Local Finance Board is hereby approved, and the Borough's Bond Counsel, Auditor and other representatives of the Borough, are hereby authorized to prepare such application and to represent the Borough in matters pertaining thereto.

Section 2. The Clerk of the Borough is hereby directed to prepare and file a copy of the proposed ordinance and this resolution with the Local Finance Board as part of such application.

Section 3. The Local Finance Board is hereby respectfully requested to consider such application and to record its findings, recommendations and/or approvals as provided by the applicable New Jersey Statute.
