WHEREAS, that in accordance with N.J.S.A. 40A:11, et. seq., The Borough of Glen Ridge used a fair and competitive process to solicit bids for the aforesated project; **and,**

WHEREAS, on August 28, 2014, D & L Paving Contractors, Inc., 681 Franklin Avenue, Nutley, NJ 07110 submitted the lowest responsible bid in the amount of **\$119,850.00; and .**

WHEREAS, through the course of the construction project additional retaining wall work and paving was performed; **and,**

WHEREAS, the proposed change order has been reviewed and verified by the project engineer; **and,**

WHEREAS, The Chief Finance Officer has certified the availability of funds for this contract from capital ordinance 1612.

NOW, THEREFORE, BE IT RESOLVED, that a change order in the amount of **\$6,218.60** is hereby approved bringing the total project cost to **\$126,731.40.**
