GRANT AGREEMENT  
BETWEEN  
BOROUGH OF GLEN RIDGE

**WHEREAS,** The Mayor and The Borough Council of The Borough Of Glen Ridge desires to further the public interest by obtaining a grant from The State of New Jersey in the amount of \$ 2,000 to fund the following project:

**COMMUNITY FOREST MANAGEMENT PLAN**

**WHEREAS,** the Borough Council resolves that Mayor Peter A. Hughes or the successor to the office of Mayor is authorized (a) to make application for such a grant, (b) if awarded, to execute a grant agreement with the State for a grant in an amount not less than \$ 3,000 and not more than \$ 3,000, (c) to execute [ ] any amendments thereto [ **X** ] any amendments thereto which do not increase the Grantee's obligations.

**NOW, THEREFORE, BE IT RESOLVED** that The Mayor and The Borough Council of The Borough of Glen Ridge hereby authorizes and hereby agrees to match 33.3 % of the total project amount, in compliance with the match requirements of the agreement. The availability of the match for such purposes, whether cash, services, or property, is hereby certified. 33.3 % of the match will be made up of in-kind services (if allowed by grant program requirements and the agreement ).

**BE IT FURTHER RESOLVED,** The Borough Of Glen Ridge ( grantee ) hereby agrees to comply with all applicable Federal, State, and Municipal laws, rules, and regulations in its performance pursuant to the agreement.
