**ADOPTION OF THE 2023 MUNICIPAL BUDGET**

**BE IT RESOLVED**, by the Mayor and Council of the Borough of Glen Ridge, in the County of Essex, New Jersey that the following statements of revenues and appropriations shall constitute the Municipal Budget of the Borough of Glen Ridge for the 2023 calendar year;
