### NOTICE OF APPLICATION

NOTICE OF APPLICATION, DEPARTMENT OF ENVIRONMENTAL PROTECTION, DIVISION OF WATER SUPPLY & GEOSCIENCE, TRENTON, NEW JERSEY. Pursuant to provisions of the Water Supply Management Act, N.J.S.A. 58:1A-1 *et seq.*, the Montclair Township Water Bureau, 54 Watchung Avenue, Montclair, New Jersey 07043 filed an application on February 5, 2010, for approval to divert a maximum of 94 million gallons of water during any month (mgm), not to exceed 1,026 million gallons per year (mgpy) at a maximum diversion rate of 2,238 gallons per minute (gpm) from existing wells 1, 2, and 3 and new well number 4. Montclair currently has approval to divert 57 mgm, not to exceed 580 mgpy at a maximum diversion rate of 1,388 gpm. The requested diversion increase will be pumped by new well number 4. The diversion rates for wells 1, 2, and 3 will not change. Well 4 is located in Nishuane Park. Diversion is to be used for public supply.

NOTICE IS HEREBY GIVEN that a public hearing will be scheduled regarding this application if comments, requesting that a hearing be held, are received from any person, including the applicant or the Department. All comments must be received no later than February 27<sup>th</sup>, 2012 and submitted to:

If a timely request is received during this period, or if it is determined by the Department that a hearing would be in the public interest, public notice will be given in order to schedule a public hearing pursuant to N.J.A.C. 7:19-2.8.

If no hearing is held, the decision maker shall make a final determination whether or not to issue the permit and the conditions to be contained therein.
