Dear Mr. Rohal:

Please find enclosed a copy of the fully executed Order to Revalue adopted by the Board on March 1, 2012. The Order to Revalue was formally approved by Michael Bryan Acting Director, Division of Taxation, on April 4, 2012.

This notice is also to advise you of the Borough's right of appeal. In the event the Borough wishes to challenge this Order a complaint must be filed with the Clerk of the Tax Court within forty-five (45) days of this notice.

Additionally, Section 8 of the Order requires that your district's tax maps be submitted for review to the Chief of the Engineering Section, Property Administration, Document Control Center, State of New Jersey, Department of Treasury, Division of Taxation, Local Property Tax, P.O. Box 251, Trenton, New Jersey, 08695-0251, Attn: Sue Davison.

Finally, the Administrative Code rules require that the Assessor and other municipal officials prepare and execute a plan for the revaluation of all real property. **N.J.A.C.** 18:12A-1.14(2), requires the assessor to submit a written report within 30 days of receipt of this Order. Copies of the required report are enclosed. This plan is to be updated monthly until the completion of the revaluation.

Please be reminded that the new cost schedules and corresponding cost conversion factors for the <u>Real Property Appraisal Manual for New Jersey Assessors</u>, Third Edition must be used for all reassessment and revaluations to be implemented for the 2004 tax year and thereafter.



Dear New Jersey State Legislatures:

We the C.U.F.F.S. Committee (Communities United For Family Safety) are sending this letter in support of the Jessica Lunsford Act. We have been in full support of this legislation for many years. We have been to many of your offices lobbying for our State legislatures to get it passed in New Jersey. Now, more than ever, we feel this is the time to pass and enact the Jessica Lunsford Act. As you are all aware, the New Jersey State Supreme Court ruled that the municipalities cannot be in control of designating "child safety zones", which would prohibit registered sexual predators from residing near or loitering in places where children regularly congregate.

Most states have already passed the Jessica Lunsford Act into law. New Jersey is one of only 8 states without this law enacted. We are confused and dismayed as to why our great State has failed to do so. Are our children not worthy of such legislation that will seek tougher penalties on those harboring and abetting registered sex offenders? Are our children not entitles to have designated safety zones, such as playgrounds, schools, schoolyards, daycare centers and such? Does it offend the legislatures to impose mandatory sentencing for crimes in which our innocent children are attacked viciously, suffer rape and even violent deaths? How many victimized children does it take to give New Jersey a wake-up call? Too many have waited to long. The safety of children should be our first and foremost concern and should supercede the rights of any known sex offender.

Therefore, we are now imploring each and every one of you, at this time, to act without haste in getting this act passed so our children and families in New Jersey have these protections and recourses which are duly deserved.
