Dear Mayor Hughes:

Enclosed is one copy of the executed Agreements approved by the Department of Transportation for the above referenced project in the amount of **\$244,000.00**.

This project will be funded from the New Jersey Transportation Trust Fund Authority Act. State participation in the cost of the project is limited to 100 percent of the cost of the completed construction work including construction supervision, inspection and material testing, or the amount of the allotment, whichever is less.

The construction contract must be awarded within 18 months from the date of the execution of the Agreement. Failure to make an award by **11/21/15** or to comply with the requirements of the Municipal Aid Regulations 16:20B and the Terms and Conditions of Grant Agreement for State Aid to Counties and Municipalities will jeopardize the use of State funds on this project. It is further noted that the project must be in compliance with the Americans with Disabilities Act, ADA, requirements for accessibility. 



GLEN RIDGE PLANNING BOARD**

TAKE NOTICE that **MONTCLAIR HOSPITAL, LLC, D/B/A HACKENSACK UMC MOUNTAINSIDE** owner of property located at **1 BAY AVENUE**, filed an application before the Glen Ridge Planning Board for amended site plan approval to construct a front yard parking/loading area near the intersection of Bay and Highland Avenues.

The property is located in the H - Healthcare Zone and is designated as lots 18 and 35 in block 92 according to the Glen Ridge Borough Tax Maps and lot 1 in block 4214 and lot 1 in block 4215 according to Township of Montclair Tax Maps.

I am writing to you jointly concerning a safety issue I have on my street.

I live on Benson Street, a road that as you may know is only a block long in Glen Ridge and a block long in Bloomfield. It also has a stop sign at both the corners of Clinton Rd and Essex Ave.


The stop signs are routinely ignored by a vast majority of motorists and the speed on the road (even for those coming over the railroad tracks near the Benson Street Station) is in excess of thirty-five miles an hour. If I had to hazard a guess I would think the normal speed for most people traveling in either direction would be close to forty miles an hour.

I'm not quite sure what saves us from having the same type of accidents that were common place on Osborne but last weekend two cars came perilously close to having just such a t-bone type accident due to speed and the ignoring of a stop sign, (and that's only the one that I witnessed recently).

I am respectfully requesting some type of traffic study (or an unmarked car with radar gun) done in this area so that we can address these issues.
