Dear Michael,

Your staff has been alerted to the Cassidian MAARS End of Life Announcement in 2008. In each of the next three years Verizon followed up the Cassidian announcement by reminding its customers of the MAARS product retirement. These follow up communications included important information related to the supportability of the MAARS VESTA Standard /VESTA EX Systems, MAARS ElectroKey Systems or MAARS ComCentrex Systems (including MAARS View).

The Cassidian announcements indicated new parts for these E-911 MAARS products would no longer be available after September 1, 2011

Verizon's standard maintenance coverage ended September 30, 2011. In an effort to meet the needs of your community, Verizon is finalizing a limited maintenance coverage offer. This offer will extend support to June 30, 2012 with no extension of coverage beyond this date. Your account team will have a formal contract document available for your signature on or before October 28, 2011.
