Re: Award to Glen Ridge Borough Township – Municipal Complex Generator Project, Under HMGP-DR-4086-NJ-0485-R

This office is pleased to inform you that the Federal Emergency Management Agency (FEMA) has awarded Glen Ridge Borough Township a Hazard Mitigation grant for a generator project. The period of performance is October 28, 2015 through October 28, 2018, with an expenditure deadline of October 28, 2017. The total project cost is \$165,650.00 with a Federal share of \$153,635.00 (split with \$45,500.00 from the Energy Allocation Initiative Program and \$108,135.00 from the Infrastructure Program), and a non-Federal share of \$12,015.00.

A "Grantee/Sub-grantee Agreement" for this project is in the process of being developed for your endorsement and is forthcoming. Project work should not begin until the agreement is signed by both the grantee and sub-grantee. The project manager will contact you to schedule a kickoff meeting to discuss the grant requirements, execute the agreement and answer any questions you may have.

Dear Municipal Officials/Solid Waste Directors/Essex County Haulers:

Each year at this time the Essex County Utilities Authority is required by law to establish the tipping fees for processible and non-processible solid waste for the coming year.

As a result the ECUA has set the following tipping fees for 2016, commencing as of January 1, 2016.

Municipal/Commercial Processible Waste – Resource Recovery Facility

2015 TIPPING FEE RATE..... \$80.93 per ton

Non –Processible Waste – Type 13 – Waste Management Facility (Julia Street)

2015 TIPPING FEE RATE.....\$90.44 per ton

Commercial Processible Waste - Waste Management Facility (Julia Street)

2015 TIPPING FEE RATE.....\$90.50 per ton

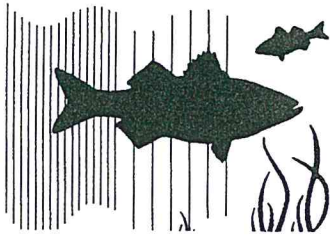
The ECUA is pleased to highlight the substantial decrease in the tipping fee for municipal processible waste (Type 10) from \$82.99 to \$80.93. There is also a reduction in the rate for commercial Type-10 waste from \$91.29 to \$90.50. These decreases are derived from a surplus that was attained through expenditure reductions, fiscal responsibility and management oversight.

The tipping fee for non-processible waste saw a slight increase to \$90.44 which is due to a new contract for waste disposal. This new contract reflects the industry-wide increase in fees for disposing of this non-recyclable type of waste.

The ECUA continues its pledge to maintain the lowest tipping rates possible. The tipping fee for our twenty-two Essex County municipalities remains the lowest of the northern New Jersey Counties.

The Passaic River Coalition continues to pursue initiatives to protect our drinking waters, improve our water quality, reduce flood damages and promote river restoration. We continue to preserve open space and promote natural flood control management by working with municipalities to develop solutions and partnerships that benefit our communities. As part of the Passaic River Watershed Basin, we welcome assisting your municipality with specific issues regarding our water resources.
