













The purpose of the amendment would revise the Land Use Plan, Map III-2 of the City of East Orange Master Plan, Land Use Element, to reclassify multiple lots fronting on Central Avenue from High Density Residential, Residential/Office, or Hospital/Institutional uses to Central Business District uses.

Following the conclusion of public comment, formal action to adopt this amendment may be taken by the Planning Board.
