Councilor Lefkovits, Chair of the Public Works Committee, reported that during last week's snow storm, the entire DPW crew was out salting and plowing the roads as well as clearing Borough properties. Three crew members stayed throughout the evening to focused on keeping the catch basins open in order to gather the melting snow and rain. 75 tons of salt and 2,000 pounds of calcium chloride pellets were used.

Since our last meeting, the Road Crew was out patching pot holes. 2.25 tons of temporary patching material were used throughout the Borough. In the spring, the potholes will be permanently patched.

Bids are due for the 2016-17 Road Project on February 22, 2018 at 10:00 a.m. Streets included in the program include, Dodd Street, Sunset Avenue, Avon Place, Cambridge Road, Herman Street, Edgewood Road, Old Oak Road, Washington Street (from Ridgewood Avenue to the Bloomfield Township border) and Linden Avenue (from the Montclair Township border to Ridgewood Avenue). The project will be funded using NJDOT Municipal Aid grants, Community Development Block Grants and capital funds. Once the project is awarded we will announce the final scope of work and the anticipated construction schedule.

Councilor Murphy, Chair of the Parks and Recreation Department, reported that the recreation department just successfully completed another Friday Night Rec season at the Ridgewood Avenue school. The Spring Sports season begins on Friday, March 2nd. The Essex County Parks Department has graciously permitted the Borough to install a storage container at Watsessing Park allowing GRAA to safely store their equipment at the field. Glen Ridge Recreation Day Camp and The Glen Ridge Community Pool will extend their seasons to accommodate the earlier closing of school this year.

A RESOLUTION HONORING THE LIFE AND ACCOMPLISHMENTS OF HORACE ASHENFELTER AND DEDICATING HAWTHORNE AVENUE BETWEEN MAOLIS AVENUE AND CARTERET STREET IN HIS NAME

WHEREAS, Horace Ashenfelter III was born on January 23, 1923, to Horace Ashenfelter and Martha Ashenfelter in Phoenixville, Pennsylvania, and raised on a farm in Collegeville, Pennsylvania. Horace graduated from Collegeville Trapp High School in 1941. He enrolled at Penn State, and spent one year there prior to enlisting into the U.S. Army Air Corps where he was a fighter pilot, and was stationed in Florida as an aerial gunnery officer until 1945 when he married his wife, Lillian Wright, and resumed

his education at Penn State. He graduated in 1949, and completed his master's degree in 1955; **and**

WHEREAS, While Horace was attending Penn State, he won two NCAA Titles, the 1948 NCAA Cross Country Champion and the 1949 NCAA Two Mile track champions. He was also a member of a four-mile relay for Penn State that won the Penn Relay Championship, which included both his brothers, Bill and Don. After college he served as a special agent in the FBI from 1950 to 1959, and continued his track career as a member of the New York Athletic Club (NYAC); and

WHEREAS, Horace claimed his most dramatic victory when he won the 1952 Olympic Gold Medal and set a world record of 8 minutes, 45.4 seconds at the Helsinki Olympics in the 3000-meter steeplechase beating the event favorite Vladimir Kazantsev of the Soviet Union. He received a congratulatory telegram from J. Edgar Hoover for his accomplishment at Helsinki. No American has won that event at the Olympics since that time; and

WHEREAS, Horace continued to run competitively until 1957, and was one of the premier track athletes during that time. He won 15 national AAU championships and set a new indoor world record in the two-mile run in 1954. He was also awarded the prestigious Sullivan Award in 1952, presented to the U.S. Amateur Athlete of the Year. He was a member of the 1956 Olympic track team in Melbourne, Australia.

WHEREAS, Horace has been inducted into several Halls of Fame including those at Penn State, the New Jersey Sports Hall of Fame, the USA Track Hall of Fame, and the NYAC Hall of Fame. The indoor track at Penn State was dedicated and named in his honor; and his Olympic gold medal is on display at the Penn State Sports Museum at Beaver Stadium. The Borough of Glen Ridge has named the annual Thanksgiving Day Run in his honor; the Ashenfelter 8K, and raised money for the Glen Ridge Educational Foundation.

WHEREAS, Horace and his wife Lillian, along with their four children were longtime residents of the Borough of Glen Ridge and spent countless hours volunteering their time for the Borough and Freeman Gardens. In addition, Horace was one of the founding members of the Glen Ridge Athletic Association in 1954, which still serves the youth of Glen Ridge.

WHEREAS, Horace peacefully passed away on January 6, 2018 leaving behind his beloved wife of 72 years, Lillian, their four sons and their wives. He is also survived by twelve grandchildren and four great-grandchildren.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Glen Ridge as follows: That the Council, for its members, the officers and employees and the people of the Borough of Glen Ridge, extend to the family of Horace Ashenfelter fondness for their departed husband, father and grandfather and commemorate him as we dedicate Hawthorne Avenue between Maolis Avenue and Carteret Street in his name. We honor Horace's memory of kindness and dedication by naming that portion of roadway "Horace Ashenfelter Way".
