

A **REGULAR** Meeting of The Mayor And Borough Council of The Borough Of Glen Ridge was held on Monday, March 27<sup>th</sup>, 2017 in the Council Chamber of The Municipal Building, Glen Ridge, New Jersey at 7:30 p m.

Mayor Patrick led The Council and the citizens in attendance in a Salute to the Flag.

Mayor Patrick read a prepared statement that adequate notice of this meeting has been provided to the public as required by statutes.

Present: Mayor Patrick, Councilors Hughes, Lisovicz, Lefkovits, Dawson, Murphy, and Morrow.

Absent: None.

The following Borough Officers were in attendance: Borough Attorney Malyska and Public Safety Director Byron - Lagattuta.

It was moved by Councilor Lisovicz, seconded by Councilor Dawson, that the Minutes Of The **REGULAR** Meeting of The Mayor And Borough Council of The Borough Of Glen Ridge that was held on Monday, **March 13<sup>th</sup>**, 2017 be approved as submitted. The Motion was adopted by an aye and no vote. Councilors Hughes, Lisovicz, Dawson, Murphy and Morrow voting aye, Lefkovits abstaining, and noes none.

Municipal Clerk Rohal presented the following written communications:

A letter to Municipal Clerk Rohal from John Wynn, Chair, Montclair Planning Board advising of a Public Hearing on an amendment to the Montclair Land Use and Circulation Element of The Master Plan on March 27<sup>th</sup>, 2017 in the Montclair Council Chambers. Mayor Patrick ordered that the correspondence be filed.

A letter to Administrator Rohal from Joan Codey Durkin, Essex County Tax Administrator, advising that the Essex County Tax Board has adopted a Resolution ordering Glen Ridge to perform a revaluation and requesting Glen Ridge tax maps for initial inspection be sent to the State Of New Jersey. Mayor Patrick ordered that the correspondence be filed.

A letter to Mayor Patrick from Cheryl H. Burstein, Mayor, Township Of Millburn, and sent to Assemblyman John Burzichelli, urging support of introduced Bill No. 2452, which would create a new category of liquor licenses for certain restaurants and to permit municipalities to issue these restricted liquor licenses regardless of population. Mayor Patrick ordered that the correspondence be filed.

Ms. Lynn Vande Stouwe, of 58 Essex Avenue approached the council to discuss a resolution for Glen Ridge to become a Sanctuary City. She also submitted a petition to the Mayor and council with 501 signatures in support of a sanctuary city resolution.

Mr. Timothy King, of 206 Forest Avenue, approached the council in reference to specific Attorney General Guidelines that may apply to the sanctuary city resolution.

Ms. Lori Jean Moodie, of 86 Oxford Street thanked the council and police department for their commitment to open communication and community policing within the Borough.

Councilor Murphy thanked the petitioners for working hard to bring the sanctuary city resolution forward.

Mayor Patrick explained the next steps for moving forward in drafting a resolution for the council to vote on.

Ms. Marisela Santiago also thanked the council for the dedication and commitment to the sanctuary city resolution.

Mr. Peter Seymour presented the council with a summary prepared by his insurance company access board about the truncated domes and the potential hazard they create for the blind.

Ms. Jennifer Breuer thanked the council for supporting the Glen Ridge Library by awarding them a 2017 Film Fund Grant for their program Selected Shorts. She invited all the members of the council to attend.

Gator bags will be installed around the newly planted trees. The Shade Tree Commission has worked closely with the Forester in identifying planting locations. Letters have been sent to all property owners that are to receive a tree. Planting location will be adjusted once the feedback from residents is provided.

Councilor Murphy noted all the events and hard work of the Glen Ridge Police Department highlighted in the 2016 Annual Report.

Councilor Hughes noted the passing of former Council Member Myles Sachs, a longtime resident of Glen Ridge with a passion for volunteering and giving back to the town.

Borough Administrator Rohal spoke to the hard work, dedication and character of Mr. Sachs and expressed his sincere condolences.
