A letter to Mayor Patrick and The Borough Council from James P. O'Grady, Parade Committee Chair of the Kiwanis Club offering their services in coordinating the Borough's 2016 Memorial Day parade and ceremony. Acting Mayor Kinley ordered that the correspondence be filed.

Acting Mayor Kinley reported that the Borough's 2016 Municipal Budget will be introduced tonight. Upon introduction, a copy of the municipal budget will be sent to the State of New Jersey for review and approval. The State reviews each municipalities budget to protect the tax payer and ensure compliance with the State budget laws. While the official State budget document has been in use for decades, the format of the budget document is very technical in nature.

In 207, Governor Chris Christie signed a law requiring a plain language "user-friendly" budget form to be created. This year, 2016, is the first year that the user-friendly budget is required by the State upon introduction. The goal of the user-friendly budget is to summarize the Borough's annual operations in a way that will make it more transparent and accessible to both the average taxpayer and to governing body. The user-friendly budget is still a work in progress and will continue to evolve in an effort to provide the public with a clearer understanding of how their tax dollars are being spent.

Acting Councilwoman Hausmann, Acting Chairperson of The Finance And Administration Committee, reported that The primary function of the Finance and Administration Committee is the oversight of the finances of the Borough. This involves preparation of the annual budget for the borough, which in turn sets the budgets for the various departments, like public safety and public works, and ultimately determines the amount of tax that has to be raised each year.

The budget process begins with presentations by each department of their needs for the New Year. Once all of the needs have been collected they are put into a preliminary budget for review by the Mayor and Council. After a series of meetings and discussions, a final budget and tax rate are voted on and the budget is then sent to the State of New Jersey for final review. Once approved, the budget is then put in place and new tax rates set.

During the year, the finance committee monitors the spending of each department. It also advises the Borough Administrator, Michael Rohal, on personnel and human resource matters as they arise. Currently we are working with Mike Zichelli to review and improve safety procedures in our Public Works department.

Overall the budget is in good shape. We are working within the State imposed 2% cap on expenditure growth while maintaining all of the services that our residents expect.

The biggest issue that we face in 2016 is the renegotiation of contracts with our 2 unions.

Hurrell Field Carteret Park, including the playground & hockey rink Forest Avenue Field Freemen Tennis Courts Clay Field, including the platform tennis court and playground. The newly renovated Washington Field The Glen Ridge Community Pool The Glen Ridge Senior Center And The Park at the Glen

I'm currently focused on the complete renovation of Carteret Park which will include the expansion and re-grading of the natural grass athletic field and the installation of new state-of-the-art playground equipment. The estimated cost of these needed improvements to Carteret park will be around \$400,000. The renovation will be done in stages with the initial play-ground stage done by June 30th, taking 30 days to complete.

The improvement to Carteret Park comes on the heels of the complete renovation of Washington Field.

Washington Field "SPORTS" the Borough's first synthetic grass, athlete-friendly cork overlaid surface... One of the first installations of such a surface in the Country.

The use of all these facilities is coordinated by Jim Cowan, the Borough's Recreation Director. Between the GRAA and the High School Athletic programs Mr. Cowan's job of juggling our limited filed space is difficult at best... and he does an outstanding job.

I also direct two running events: The Ashenfelter 8K Classic and the Fitzgerald's Lager Run. These events raise money for two local charities, namely The Glen Ridge Educational Foundation and the Glen Ridge Community Fund.
