**WHEREAS**, when a local governmental contracting unit experiences an emergency that meets the requirement of law, a waiver of Chapter 19 is automatically granted, as

long as the requirements of The Local Public Contracts Law, specifically N.J.S.A. 40A:11-6 and the rules at N.J.A.C. 5:34-6.1 are met; and,

**WHEREAS**, after an inspection of the rail road right of way by New Jersey Transit staff, several trees were identified on Glen Ridge owned property that could compromise the health and welfare of the commuters, employees and residents, and this finding required the immediate performance of services; and,

**WHEREAS**, Dujets Tree Experts, Inc. of 54 Notch Road, West Paterson, New Jersey 07024 has been contracted to remove the hazardous trees; and,

**WHEREAS**, the Chief Finance officer certified the availability of funds for this contract from the current fund; and,

**NOW, THEREFORE, BE IT RESOLVED** by The Mayor and Council of The Borough of Glen Ridge that Dujets Tree Experts, Inc. be awarded the contract for the Emergency Tree Service Project in the amount of **\$6,600.00**; and,

Councilor Murphy, Chair of the Parks and Recreation Committee extended his gratitude to the GRPD, DPW, Community Fund and volunteers for all of their hard work involved in making the annual Fitzgerald’s Lager Run and the new “Nipper Mile” a huge success this year.

Councilor Morrow reported that he has Ordinance No. **1684** entitled:

**THE REDEVELOPMENT PLAN FOR THE BALDWIN STREET REDEVELOPMENT AREA**

for introduction. The Ordinance title was read by Councilor Morrow. It was moved by Councilor Morrow, seconded by Councilor Lefkovits that Ordinance No. **1684** be passed on first reading. Mayor Patrick referred the Ordinance to Municipal Clerk Rohal for the purposes of statutory publication and posting.

Borough Clerk Rohal reported that the next council meeting regularly scheduled for July 9, 2018 has been rescheduled to July 16, 2019. He reminded residents that this Thursday evening Bloomfield will be holding the annual Tom Fleming Sunset Classic and they should be aware of street closures. Estimated tax bills will be mailed out this week and are due August 1<sup>st</sup>.

Borough Attorney Malyska stated that the Borough is very close to a resolution for the Baldwin Street Builder's Remedy lawsuit. Concept drawing would be presented soon for a 110-unit residential apartment building built on 2.1 acres of land. The ordinance will be presented for second reading on July 16, 2018. The planning board will also be reviewing a borough wide Affordable housing plan at their August meeting which will then be present to council.

Captain Quinn reminded residents to be diligent in locking their vehicles as the Borough has seen an increase in entered vehicles.

**SELF-EXAMINATION OF BUDGET RESOLUTION**

WHEREAS, N.J.S.A. 40A:4-78b has authorized the Local Finance Board to adopt rules that permit municipalities in sound fiscal condition to assume the responsibility, normally granted to the Director of the Division of Local Government Services, of conducting the annual budget examination; and

WHEREAS, N.J.A.C. 5:30-7 was adopted by the Local Finance Board on February 11, 1997; and

WHEREAS, pursuant to N.J.A.C. 5:30-7.2 through 7.5, the Borough of Glen Ridge has been declared eligible to participate in the program by the Division of Local Government Services, and the Chief Financial officer has determined that the local government meets the necessary conditions to participate in the program for the 2018 budget year.

NOW THEREFORE BE IT RESOLVED by the governing body of the Borough of Glen Ridge that in accordance with N.J.A.C. 5:30-7.6a & 7.6b and based upon the Chief Financial Officer's certification, the governing body has found the budget has met the following requirements:

1. That with reference to the following items, the amounts have been calculated pursuant to law and appropriated as such in the budget:
  - a. Payment of interest and debt redemption charges
  - b. Deferred charges and statutory expenditures
  - c. Cash deficit of preceding year
  - d. Reserve for uncollected taxes
  - e. Other reserves and non-disbursement items
  - f. Any inclusions of amounts required for school purposes.

2. That the provisions relating to limitation on increases of appropriations pursuant to N.J.S.A. 40A:4-45.2 and appropriations for exceptions to limits on appropriations found at N.J.S.A. 40A:4-45.3 et seq., are fully met (complies with CAP law).

3. That the budget is in such form, arrangement, and content as required by the Local Budget Law and N.J.A.C. 5:30-4 and 5:30-5.

4. That pursuant to the Local Budget Law:

- a. All estimates of revenue are reasonable, accurate and correctly stated,
- b. Items of appropriation are properly set forth
- c. In itemization, form, arrangement and content, the budget will permit the exercise of the comptroller function within the municipality.

5. The budget and associated amendments have been introduced and publicly advertised in accordance with the relevant provisions of the Local Budget Law, except that failure to meet the deadlines of N.J.S.A. 40A:4-5 shall not prevent such certification.

6. That all other applicable statutory requirements have been fulfilled.

BE IT FURTHER RESOLVED that a copy of this resolution will be forwarded to the Director of the Division of Local Government Services upon adoption.

Mayor Patrick called for comments of the public. No comments were made.

It was moved by Councilor Mans, seconded by Councilor Lisovicz that this meeting be adjourned. The Motion was adopted by an aye and no vote.
