Councilman Dawson, Chairman of The Public Works Committee, reported that as part of our shared service agreement with Montclair, the Montclair Fire Department has completed the 2016 Spring hydrant flushing program. Councilman Dawson reported that flushing is done to remove sediment from the pipes in order to maintain water clarity and the quality in the distribution system. The flushing also alerts us to any issues we may have with our fire hydrants.

Councilman Dawson also reported that a preconstruction meeting was held with Turco Golf, Inc. regarding the Carteret Field improvements. The construction company is mobilizing their crew this week and getting the site ready for work.

Councilman Murphy, Chairman of The Parks And Recreation
