

A **REGULAR** Meeting of The Mayor And Borough Council of The Borough Of Glen Ridge was held on Monday, June 22<sup>nd</sup>, 2015 in the Council Chamber of The Municipal Building, Glen Ridge, New Jersey at 7:30 p m.

Council President Lefkovits led The Council and the citizens in attendance in a Salute to the Flag.

Council President Lefkovits read a prepared statement that adequate notice of this meeting had been provided to the public as required by statutes.

Present: Councilpersons Patrick, Dawson, Murphy, Morrow and Council President Lefkovits.

Absent: Mayor Hughes And Councilman Lisovicz.
