A **REGULAR** Meeting of The Mayor And Borough Council of The Borough Of Glen Ridge was held on Monday, July $9^{\rm th}$, 2012 in the Council Chamber of The Municipal Building, Glen Ridge, New Jersey at 7:50 p m.

Mayor Hughes led The Council and the citizens in attendance in a Salute to the Flag.

Mayor Hughes read a prepared statement that adequate notice of this meeting had been provided to the public as required by statutes.

Present: Mayor Hughes, Councilpersons Patrick, Lisovicz, Dawson, Theodorou and Baker.

Absent: Councilman Lefkovits.

The following Borough Officers were in attendance: Borough Attorney Malyska and Police Chief Byron - Lagatutta.

The Minutes Of the **REGULAR** Meeting of The Mayor And Borough Council of The Borough Of Glen Ridge that was held on Tuesday, June $25^{\rm th}$, 2012 were approved as submitted.

Municipal Clerk Rohal presented the following written communications:

A letter to Borough Administrator Rohal from Frank Santomauro, P.E. Chief Planning Division, U.S. Army Corps of Engineers, advising of a State And Federal cost shared Feasibility level study to determine if flood risk management opportunities are advisable for the Passaic River Watershed in New Jersey and New York. Mayor Hughes ordered that this correspondence be filed.

A letter to Mayor Hughes from Essex County Executive Joseph N. DiVinceno, Jr., inviting Glen Ridge to join the Essex County Transportation Advisory Board and requesting that Glen Ridge appoint a representative to serve on the Advisory Board. Mayor Hughes ordered that this correspondence be filed.

A letter to Administrator Rohal that was also sent to Dara Callender, P.E., State Of New Jersey, Natural And Historic Resources, acknowledging receipt of the Glen Ridge revised Application for Project Authorization (application) for the Glen Ridge Station Stair Repair Project. Mayor Hughes ordered that this correspondence be filed.

A letter to Municipal Clerk Rohal from Alexander C. Stern, Law Department, PSEG Services Corporation, advising of a Notice Of Filing for Approval of changes in its Electric and Gas RGGI Recovery Charges; and for Changes in the Tariff for Electric Service and the Tariff for Gas Service pursuant to the statutes. Mayor Hughes ordered that this correspondence be filed.

Mr. Patrick Pignatello of 277 Baldwin Street, Glen Ridge, reported on some volunteer maintenance work that he had done on the bus stop at Bloomfield And Ridgewood Avenues.

Mayor Hughes thanked Mr. Pignatello for all the volunteer work that he does for the Borough.

Mayor Hughes presented the following comments in regards to rumors of a synthetic field at Hurrell Field:

- 1. Support for a synthetic field surface at hurrell field within at least a portion of the sporting community in GR has not gone away.
- 2. A group from within the sporting community has indicated that they have significant financial backing for the project
- 3. In an era of very tight budgets, the Mayor believes that we have to consider the cost benefits of a synthetic field surface funded in large part by private donations.
- 4. First step is to determine if private funds are truly available. Pledge form has been created and circulated. Time line for response.
- 5. If pledges are made that are substantial enough to warrant a next step (\$ in excess of \$350K), Mayor would consult with Council and ask that a non-binding referendum be put on the November ballot asking Town if it is in support of a synthetic playing surface at hurrell.
- 6. Cost estimate is approx. \$1M\$ with \$700K coming from private donations and \$300K from Town. If successful on referendum and if approved by the Council, actual installation would occur in the summer of 2013.
- 7. Plan would not include lights and would be limited to Hurrell field.
- 8. Field control does not change. The Town remains the final say on field usage.
- 9. Field would be striped for up to 4 sports including baseball. We could add tick marks for all sports to cover the possibility of additional usage. Temporary paint lasting up to 3 months would be used if a new sport were added.
- 10. Field Hockey on Hurrell is a real possibility for home games if not practices. This would greatly improve conditions for the girl's team and reduce maintenance costs at Forest.

Councilman Theodorou reported that a town-wide referendum a few years ago resulted in the turf proposal being defeated and the Borough is obligated to restore the fields to keep them playable.

Councilman Theodorou stated that a synthetic surface on Hurrell Field would mean a savings of approximately \$ 50,000 in our Municipal Budget not to mention the wear and tear on our equipment.
