The exact rate for the position shall be established by a Resolution of the Governing Body. Said compensation or salaries shall be paid in semi-monthly installments.

**SECTION 2.** As part of the salary ordinance, the holder of the office of Chief of Police shall perform without diminution the obligations which were heretofore performed by the Director of Public Safety with respect to crossing guards and the Glen Ridge Volunteer Ambulance Squad as well as any other obligations which the Mayor and Council determine were heretofore performed by the Director of Public Safety.

**SECTION 3.** Officers and employees of The Borough of Glen Ridge may also be eligible for one-time payments for past service or performance. The officer or employee, the job title, and the one time payment amount will appear on an authorizing resolution, which must be adopted by a majority vote of the Borough Council.
