Councilor Lefkovits, Chairman of The Community Affairs and Public Relations Committee, raised concerns about obtaining a left-hand turn signal on Ridgewood Avenue turning onto Bloomfield Avenue in both directions.

The meeting will be held in the Council Chambers, second floor of the Glen Ridge Municipal Building located at 825 Bloomfield Avenue, Glen Ridge, New Jersey.

In the past two weeks, the entire DPW crew spent time cleaning up from the Ashenfelter 8k and removing leaves from Borough parks and properties.

In regards to the latest snow event, on Friday, December 8th, the Public Works Department crew applied 500 gallons of brine to our hills, bridges, Herman Street & the hospital route.

On Saturday at 1:30 pm three crew members came in to salt all Borough streets and parking lots. At 2:30pm they were joined by four additional crew members. They cleaned the municipal parking lots and Borough properties. Once complete, approximately 60 tons of salt were applied to the roadways and 350 pounds of calcium chloride were applied to walkways.

As our 2017 construction season comes to a close, I am happy to report the plaster at the Glen Ridge Community Pool has fully cured and our vendor is currently winterizing our filtration system. We are looking forward to a great 2018 season.

Additionally, John Garcia Construction is wrapping up the lead line replacement project. They have replaced all municipal lead services on Edgewood Road, Herman Street, Cambridge Road and Sunset Avenue. In the spring of 2018 these roads will be repaved.
