Councilor Murphy, Chair of the Parks and Recreation Committee announced that the annual Fitzgerald's Lager Run and the new "Nipper Mile" will be held on Sunday,

June 24, 2018. All proceeds will benefit the Glen Ridge Community Fund. Applications can be obtained online or at the Glen Ridge Train Station. He also noted that a canopy will be installed over the playground equipment at Carteret Park to shade the area after some tree removal. Work should be completed in the next few days. On June 18, 2018much of Carteret Park will be closed for two months for field maintenance. Lastly, he announced that a Liz O'Connell Glen Ridge High School Senior. placed as a Group 1 winner in both the 1600 meter and 3200-meter races, placing in 8th place in the State of New Jersey.

Councilor Morrow, Chair of the Planning and Development Committee reported that the Planning Board will be hold their next meeting on Wednesday, June 20, 2018 at 7:30 PM in the Council Chambers.

Borough Clerk Rohal reported that the Brough has made a formal application to the NJ Environmental Infrastructure Trust to replace about 700 water services. The Borough has been receiving complaints about PSE&G when they are replacing main lines and only paving half of the street, these streets will be fully paved after the completion of the water services project as well.
