## ORDINANCE NO. 1535

## AN ORDINANCE TO APPROPRIATE GRANTS FUNDS FOR VARIOUS CAPITAL IMPROVEMENTS AND EQUIPMENT

**BE IT ENACTED AND ORDAINED,** by The Mayor and The Borough Council of The Borough Of Glen Ridge, in The County Of Essex and The State Of New Jersey, as follows:

- Section 1. There shall be road improvements made to various Borough streets.
- Section 1A. The sum of three hundred and sixty thousand dollars (\$360,000.00) is hereby appropriated from The New Jersey Department of Transportation Municipal Aid Program.
- Section 1B. The sum of sixty thousand dollars (\$58,2000.00) is hereby appropriated from Community Development Block Grant Program.
- Section 2. There shall be equipment purchases for the Public Safety Department.
- Section 2A. The sum of thirty thousand dollars (\$30,000.00) is hereby appropriated from the Capital Improvements Fund.
- Section 3. There shall be equipment purchases for the Administration, Finance, Parks & Planning Departments.
- Section 3A. The sum of twenty one thousand dollars (\$ 21,00.00) is hereby appropriated from the Capital Improvements Fund.
- Section 4. There improvements shall be engineering services for capital projects.
- Section 4A. The sum of ten dollars (\$10,000.00) is hereby appropriated from the Capital Improvements Fund.
- Section 5. There improvements shall be the purchase of a used jitney & used Ford Explorer.
- Section 5A. The sum of thirty eight thousand dollars (\$38,000.00) is hereby appropriated from the Capital Improvements Fund
- Section 6. There shall be building improvements made to the Library and Municipal Building.
- Section 6A. The sum of twenty two thousand five hundred dollars (\$22,500.00 ) is hereby appropriated from the Capital Improvements Fund.
- Section 7. There shall be improvements made to Hurrell Field.
- Section 7A. The sum of two hundred and twenty five thousand dollars (\$225,000.00) is hereby appropriated from the Essex County Open Space Fund.
- Section 8. The following matters are hereby determined and declared:
  - (a) The purpose is not a current expense and is an acquisition which may be lawfully made.
  - (b) The gross debt of the Borough as defined in R.S. 40A:2-6 is not increased by this Ordinance.
