**ORDINANCE NO. 1554**

**AN ORDINANCE TO APPROPRIATE  
GRANTS FUNDS FOR VARIOUS CAPITAL  
IMPROVEMENTS AND EQUIPMENT**

**BE IT ENACTED AND ORDAINED**, by The Mayor and The Borough Council of The Borough Of Glen Ridge, in The County Of Essex and The State Of New Jersey, as follows:

- Section 1. There shall be road improvements made to various Borough streets.
- Section 1A. The sum of two hundred and ten thousand dollars ( \$ 210,000.00 ) is hereby appropriated from The New Jersey Department of Transportation Municipal Aid Program.
- Section 1B. The sum of fifty eight thousand two hundred dollars( \$ 58,200.00 ) is hereby appropriated from Community Development Block Grant Program.
- Section 2. There improvements shall be engineering services for capital projects.
- Section 2A. The sum of ten thousand dollars ( \$ 10,000.00 ) is hereby appropriated from the Capital Improvements Fund.
- Section 3. There shall be the first year capital lease payment for a front end loader.
- Section 3A. The sum of twenty thousand, eight hundred, fifty seven dollars and seventy nine cents ( \$ 20, 857.79 ) is hereby appropriated from the Capital Improvements Fund
- Section 4. There shall be the first year capital lease payment for a mason dump truck.
- Section 4A. The sum of eight thousand, nine hundred, eighty seven dollars and fifty cents ( \$ 8,987.50 ) is hereby appropriated from the Capital Improvements Fund.
- Section 5. There shall be building improvements made to the Municipal Building.
- Section 5A. The sum of twenty five thousand five dollars ( \$ 25,000.00 ) is hereby appropriated from the Capital Improvements Fund.
- Section 6. There shall be the purchase of Public Safety equipment.
- Section 5A. The sum of ten thousand dollars ( \$ 10,000.00 ) is hereby appropriated from the Capital Improvements Fund.
- Section 6. The following matters are hereby determined and declared:
- (a) The purpose is not a current expense and is an acquisition which may be lawfully made.
  - (b) The gross debt of the Borough as defined in R.S. 40A:2-6 is not increased by this Ordinance.

**BE IT FURTHER ENACTED AND ORDAINED**, that this Ordinance shall take effect immediately upon final passage and publication thereof, as provided by law.
