ORDINANCE NO. 1584

**ORDINANCE AUTHORIZING PENALTIES FOR VIOLATIONS OF THE CODE OF THE
BOROUGH OF GLEN RIDGE, COUNTY OF ESSEX, NEW JERSEY.**

BE IT ENACTED AND ORDAINED. By The Mayor and The Borough Council of The Borough of Glen Ridge, in The County of Essex and in The State of New Jersey, the Code of the Borough of Glen Ridge is amended as follows:

1.08.010 - General Penalty.

- A. Any person violating any of the provisions or failing to comply with any of the mandatory requirements of any ordinance of the borough is guilty of a misdemeanor. Except in cases where a different punishment is prescribed by any ordinance of the borough, any person convicted of a misdemeanor under the ordinances of the borough shall be punished by a fine not to exceed two thousand dollars, by imprisonment not to exceed ninety days or by such fine, community service and imprisonment.
