## **ORDINANCE NO. 1710**

## AN ORDINANCE AMENDING SECTION 10.32.and 10.35 OF GLEN RIDGE CODE

**SECTION 1** Section 10.32.010 - No parking any time is amended as follows:

53. East and West sides of High Street from Bloomfield Avenue north to a point 415 feet from Bloomfield Avenue.

54. East and West sides of Hillside Avenue from Bloomfield Avenue north to a point 260 feet from Bloomfield Avenue.

SECTION. 2 Time Limit Parking - One Hour - Seven a.m. to five p.m.

5. South side of Darwin Place from a point thirty-eight feet west of Ridgewood Avenue to Woodland Avenue.

6. North side of Woodland Avenue from Ridgewood Avenue to Darwin Place

SECTION. 3 Section 10.32.120 Time limit parking - Three Hour - Seven am to five p.m. is repealed.

**SECTION**. 4 Section 32.140 Time limit parking – Two Hour - Seven a.m. to seven p.m. is amended as follows:

22. North and south sides of Windsor Place from Ridgewood Avenue to Hillside Avenue.

North and south sides of Appleton Place.

South side of Clark Street from Ridgewood Avenue to the railroad overpass.

North side of Clark Street from Ridgewood Avenue east to the railroad overpass.

North and south sides of Snowden Place.

East and west sides of Hillside Avenue from Bloomfield Avenue south to Windsor Place.

North and south sides of Woodland Avenue.

South side of Hillcrest Road from a point on Hillcrest five hundred feet east of the intersection of Woodland Avenue to Douglas Road.

North and south sides of Lincoln Street from two hundred eighty feet west of Ridgewood Avenue to the Montclair Township border.

North and south sides of Old Oak Road.

East and west sides of Douglas Road from Woodland Avenue south to Lincoln Street.

East and west sides of Summit Street.

West side of Ridgewood Avenue from Old Oak Road south to Washington Street.

East side of Ridgewood Avenue from Appleton Place to Washington Street.

West side of Ridgewood Avenue from a point two hundred twenty-two feet north of Bloomfield Avenue north to Belleville Avenue.

North side of Glen Ridge Avenue.

West side of Washington Place.

Both sides of Marston Place from Douglas Road to the Montclair boundary.

Washington Street from the Bloomfield town line west to Ridgewood Avenue on the north and south sides of the street.

Midland Avenue from Washington Street, south to Linden Avenue on the east and west sides of the street.

West side of Edgewood Road from Park Avenue to Belleville Avenue.

East side of Edgewood Road from a point three hundred seventy-four feet north of Park Avenue on Edgewood Road continuing north to Belleville Avenue.

Highland Avenue between Baldwin Street and Belleville Avenue.

Hillside Avenue, Winsor Place south to Washington Street on the East and West Sides of the street.

Hillside Avenue between Washington Street and Linden Avenue.

B. Street parking permit placards shall be issued through the borough or police administrative office to residents for automobiles and noncommercial registered pick-up trucks and vans for use only in front of the resident's home. Applicants for such permits shall be required to present proof of residence.

Each residence within the three hours parking time limit zone will be entitled to a maximum of three permit placards at no cost. Replacement for lost or destroyed placards will be at a cost to the resident of two dollars per permit placard.

When a residence changes ownership the permit placards must be returned to the administrative office in the municipal building. The new homeowner will have to apply for the issuance of three new placards.

Permit placards issued shall be subject to all the conditions and restrictions set forth in this chapter and of the permit parking zone for which they were issued, including conditions or restrictions which may be altered or amended from time to time. The issuance of such permit shall not be construed to be a permit for, or approval of, any violation of any provisions of this code or any other law or regulation.

SECTION 5 SECTION 10.35.030 is amended as follows:

- A. On Street Parking for Faculty
- 1. Deleted
- 2.. East Side of Ridgewood from Snowden Place to Winsor Place

- 8. Lincoln Street from Ridgewood Avenue to Hamilton Road
- B. On Street Permit Parking Areas for Commuters
- 1. West side of Ridgewood Avenue from Woodland Avenue to Lincoln Street
- 2. South side of Woodland Avenue from 276 feet west of Ridgewood Avenue to Hillcrest Road.
- C. Student Parking
- 1., West side of Ridgewood Avenue between Lincoln Street and Washington Street;
- 2. East side of Ridgewood Avenue from Winsor Place to Washington Street.
- 3. Both sides Lincoln Street from Ridgewood Avenue to two hundred eighty feet west of Ridgewood Avenue is repealed

. **SECTION**. Nothing in this Chapter shall be construed to abrogate or impair the power of the Borough of Glen Ridge or any officer or department to enforce any provisions of its charter, or any other provisions of its Code or regulations promulgated thereunder, nor to prevent or punish violations thereof, and the powers conferred by this Chapter shall be in addition and supplemental to the powers conferred upon the Borough by any other law or provision of the Glen Ridge Code.

**SECTION** If any clause, sentence, subdivision, paragraph, section or part of this Ordinance be adjudged by any court of competent jurisdiction to be invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, subdivision, paragraph, section, or part thereof, directly involved in the controversy in which said judgment shall have been rendered.

**SECTION** This Ordinance shall take effect upon final passage and publication according to law.
