

## **ORDINANCE NO. 1790**

# AN ORDINANCE BY THE BOROUGH COUNCIL AMENDING THE BOROUGH OF GLEN RIDGE CODE OF ORDINANCES CHAPTER 10.35 – PERMIT PARKING ON PUBLIC STREETS

**BE IT ENACTED AND ORDAINED**, these regulations specifically amend the following ordinance(s) and regulation(s) of **Chapter 10.35 – Permit Parking on Public Streets**:

#### **SECTION 1.**

# 10.35.030 - On-street permit parking areas.

A. On Street Permit Parking Areas for Faculty. Between the hours of seven a.m. and five p.m. Monday through Friday, parking is permitted only by Glen Ridge Board of Education employees holding a valid employee parking permit on the following designated areas of the following described streets:

- 1. East Side of Ridgewood from Snowden Place to Appleton Place.
- 2. South side of Clark Street from a point seventy-five feet east of the intersection with Ridgewood Avenue to a point three hundred feet east of the intersection with Ridgewood Avenue.
- 3. North side of Clark Street from the intersection of Ridgewood Avenue to a point three hundred feet east.
- 4. North and South sides of Lincoln Street from Ridgewood Avenue to Hamilton Road.
- C. Between the hours of seven a.m. and five p.m. Monday through Friday, Student holding a valid student parking permit must only park on the following designated areas of the following described streets:
  - 1. West side of Ridgewood Avenue between Lincoln Street and Washington Street.
  - 2. East side of Ridgewood Avenue from Appleton Place to Washington Street.

### 10.35.050 - Prohibitions.

D. Any misuse of the permit is subject to being revoke by the issuing authority. Misuse is defined as, but not limited to, continued parking in the incorrect designated permit area, transferring a permit to another for use or for persistent parking offenders in violation of the ordinance. Upon the revocation of a permit, the vehicle will no longer be permitted to park in the designated area for the remainder of the permitted year. The permittee will be notified by the issuing authority via the provided contact information that the permit has been revoked by the issuing authority. The issuing authority will notify the permittee in advance if they are in danger of being revoked.

Where any section, subsection, sentence, clause, or phrase of these regulations is, for any reason, declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the regulations as a whole, or any part thereof, other than the part so declared.

**SECTION 2.** All ordinances or parts of ordinances not consistent with the provisions of this Ordinance be and the same are hereby repealed.

**BE IT FURTHER ENACTED AND ORDAINED**, that this Ordinance shall take effect immediately upon final passage and publication in accordance with the law.
