

2024 Glen Ridge Recreation Summer Day Camp FAQ's & Information

Please note this program may be modified.

- 1) **Who may participate?** Glen Ridge residents ages 5 – 12 (must be 5 years old before January 1, 2025).
- 2) **When is it?** June 19 – August 1 Monday through Friday 9:00am – 3:00pm (Times may vary. Please see calendar.)
- 3) **Where is it?** Home base is Carteret Park, Carteret Street, Glen Ridge, NJ.
- 4) **How much does it cost?** Early Bird Registration is Tuesday, February 20 through Monday, March 4 at a cost of \$40/per day. Regular Registration is Tuesday, March 5 through end of camp at a cost of \$45/per day. Please note that there will be no on-site registration. All registrations must take place online.
- 5) **How many campers will be in each session?** There will be a maximum of 40 campers per day.
- 6) **How many counselors will there be?** There will be 10 camp counselors with a mix of certified teachers and students 16 years old and older.
- 7) **What kind of activities are planned?** Sports games, arts & crafts, board games, and water games will be among the activities when the camp is not on a trip.
- 8) **Should campers bring a lunch?** Yes. Campers should bring a lunch and a filled drink/water bottle. Please note that there will be refrigeration available. The staff will encourage proper hand washing before and after lunch.
- 9) **Will there be any bus trips as in the past?** YES! Please see the calendar for trips schedule.
- 10) **What if it rains?** Day camp will not operate when inclement or dangerous weather is forecast. The staff will ensure that precautions are taken in consideration of sudden unexpected inclement weather including providing outside canopy/tenting/cover accessibility. In the event that day camp is canceled, the daily registration fee will be refunded. Call the GR Day Camp Hotline (973)748-2439 for schedule changes due to weather. The message is updated by 8:00am each day. Please do not leave messages on this line.
- 11) **Will refunds be issued if family plans change?** No. Refunds will only be issued for rained out days or extenuating family circumstances.
- 12) **Can days be switched or transferred to another camper?** No. Switching days or transferring of days to other campers is prohibited.
- 13) **Can the camp staff dispense medication or apply sunscreen to campers?** No. Staff members are not allowed to dispense medication or apply sunscreen. If your child has a food allergy, please provide the information that we need to know in writing at sign-in to camp along with epi pen. Campers should carry epi pen with them in their backpack on trips.
- 14) **How will the camp deal with disorderly conduct by campers?** Behavior such as, but not limited to, showing disrespect to a staff member, inappropriate language, continued disobedience, vandalism, fighting, theft, will not be tolerated and may result in removal from the program without a refund. Any participant that demonstrates dangerous behavior or possesses any item which does or could endanger the health or safety of him/herself and/or another will be removed from the program without refund.
