



THE HEALTH AND SAFETY RULES THE BOROUGH CODE SAYS:

All dogs must be leashed or confined to the owner's property. Dogs are not allowed in public buildings, restaurants, or stores (guide dogs excepted). Dogs may not damage, deface or deposit waste on the property of others or on public property. The "pooper-scooper" law is in effect. Dogs may not annoy neighbors by continuous barking or howling.

- Dogs must be licensed each year (New Jersey State Law). Rabies vaccination must be current through October 1, 2010. Violators of the Borough Codes may be subject to a fine.

DOG PROBLEMS

DOG LICENSES

An application is on the reverse side of this form. All dogs, seven months of age or older must be licensed every year. In order to be licensed, a dog must have a current rabies immunization. FEES – License for spayed and neutered dogs cost \$18.00; license fee for all non-sterilized dogs is \$21.00. Lower license and adoption fees for spayed and neutered animals are intended to help control the rise in the dog and cat populations and the incidence of abandonment.

2010 Dog License Application

If you own, keep, or harbor a dog of seven (7) months or older for more than ten (10) days, New Jersey State Law requires that you must obtain a 2010 Dog License during the month of January. Licensing may help reunite you with your lost or missing pet. Your fee also supports programs that enhance the welfare of animals including low-cost spaying, neutering, and rabies vaccine clinics.

NOTE: New Jersey law requires you to supply the following prior to issuing your license:

- 1.) **PROOF OF CURRENT RABIES VACCINATION** must be valid through October 1, 2010. If your dog's rabies vaccination expires prior to October please send us your dog(s) new vaccination record to keep your dog license valid. You are required to re-submit your dog's rabies vaccination record every year.
- 2.) **PROOF OF ALTERATION (SPAYED OR NEUTERED) FROM VETERINARIAN OR CLINIC**
