

## **Borough of Glen Ridge Jitney Fare Pilot Program Information**

Beginning Tuesday, February 7, 2011 anyone wishing to ride on the Jitney must pay a fare. The Jitney fare pilot program will end on Tuesday, May 31, 2011 at which time a permanent fare policy will be instituted.

### **Fee Schedule:**

Monthly Pass Card	\$25.00/month
10 Trip Books	\$20.00
One way ride purchased on Jitney	\$ 3.00 (exact change only)

Monthly Pass Cards and Trip Books may be purchased by mail. Payment and application must be received 10 days prior to the last day of the previous month to receive a Monthly Pass Card by mail. For your convenience, we encourage you to purchase your Monthly Pass Card for all four months of this pilot program at one time.

Monthly Pass Cards and Trip Books may also be purchased at Borough Hall (room 102) Monday through Friday 8:30 am – 4:30 pm and at the Ridgewood Avenue Train Station on the third and fourth Thursday of each month 3:00 pm – 7:00 pm.
