I am seeking your kind assistance for the passage of bill A4464. The bill mandates drivers involved in fatal accidents submit to a drug and alcohol testing. Also we are seeking for the passage of the bill A4461 which penalizes distracted drivers.

A recent study by MADD reports that New Jersey is one state among 14 states which remains behind the times in the passage of DUI laws. Although deaths due to DUI are decreasing nationwide by 7%; sadly, deaths due to DUI in New Jersey are on the rise, on 2011 3300 death due to distracted drivers .

As physicians with medical backgrounds, we cannot diagnose the intoxication status of an individual unless it is confirmed by a blood test. In fatal accidents police officers do not have the medical training or experience to make those decisions. Distracted drivers also have to be penalized, any one operating heavy machine should take the responsibility of being 100% alert.

My daughter, Michelle, lost her life when was struck by a vehicle that swerved to the parking lot and was dragged and thrown over 100 feet a head ,he did not even slam the break. He said (I thought I hit a dear).

No tests were performed on the driver.

No summon was issued

My daughter, Michelle lost her life on St. Patrick's Day, of this year at the age of 17. She was never able to neither graduate from high school with honors as she supposed to, nor accept the scholarship she was awarded.

This was not an accident but a horrible tragedy that will cause unending pain.

SYNOPSIS

Requires blood sample to be obtained from driver involved in motor vehicle accident resulting in death; designated as "Michelle's Law."

CURRENT VERSION OF TEXT

As introduced.

AN ACT concerning motor vehicle accidents resulting in death, designated as "Michelle's Law" and amending R.S.39:4-50, P.L.1966, c.142 and P.L.1981, c.512.

BE IT ENACTED by the Senate and General Assembly of the State of New Jersey:

1. R.S.39:4-50 is amended to read as follows:

39:4-50. (a) Except as provided in subsection (g) of this section, a person who operates a motor vehicle while under the influence of intoxicating liquor, narcotic, hallucinogenic or habit-producing drug, or operates a motor vehicle with a blood alcohol concentration of 0.08% or more by weight of alcohol in the defendant's blood or permits another person who is under the influence of intoxicating liquor, narcotic, hallucinogenic or habit-producing drug to operate a motor vehicle owned by him or in his custody or control or permits another to operate a motor vehicle with a blood alcohol concentration of 0.08% or more by weight of alcohol in the defendant's blood shall be subject:

(1) For the first offense:

(i) if the person's blood alcohol concentration is 0.08% or higher but less than 0.10%, or the person operates a motor vehicle while under the influence of intoxicating liquor, or the person permits another person who is under the influence of intoxicating liquor to operate a motor vehicle owned by him or in his custody or control or permits another person with a blood alcohol concentration of 0.08% or higher but less than 0.10% to operate a motor vehicle, to a fine of not less than \$250 nor more than \$400 and a period of detainment of not less than 12 hours nor more than 48 hours spent during two consecutive days of not less than six hours each day and served as prescribed by the program requirements of the Intoxicated Driver Resource Centers established under subsection (f) of this section and, in the discretion of the court, a term of imprisonment of not more than 30 days and shall forthwith forfeit his right to operate a motor vehicle over the highways of this State for a period of three months;

(ii) if the person's blood alcohol concentration is 0.10% or higher, or the person operates a motor vehicle while under the influence of narcotic, hallucinogenic or habit-producing drug, or the person permits another person who is under the influence of narcotic, hallucinogenic or habit-producing drug to operate a motor vehicle owned by him or in his custody or control, or permits another person with a blood alcohol concentration of 0.10% or more to operate a motor vehicle, to a fine of not less than \$300 nor more than \$500 and a period of detainment of not less than 12 hours nor more than 48 hours spent during two consecutive days of not less than six hours each day and served as prescribed by the program requirements of the Intoxicated Driver Resource Centers established under subsection (f) of this section and, in the discretion of the court, a term of imprisonment of not more than 30 days and shall forthwith forfeit his right to operate a motor vehicle over the highways of this State for a period of not less than seven months nor more than one year;

(iii) For a first offense, a person also shall be subject to the provisions of P.L.1999, c.417 (C.39:4-50.16 et al.).

The Assembly Transportation, Public Works and Independent Authorities Committee reports favorably Assembly Bill No. 4461.

As reported, this bill prohibits a driver from engaging in any activity, not related to the operation of the vehicle, in a manner that interferes with the safe operation of the vehicle. A law enforcement officer is to record on the summons the specific nature of the distracted driving behavior. A violation of this prohibition will result in a fine of not less than \$200 or more than \$400 for the first offense, not less than \$400 or more than a \$600 for a second offense, and not less than \$600 or more than \$800 for a third or subsequent offense. A third or subsequent violation may also result in a driver's license suspension of up to 90 days and motor vehicle penalty points at the court's discretion.

This bill also amends the existing law prohibiting the use of a hand-held wireless telephone while operating a motor vehicle by establishing a permissive inference that a driver holding a cell phone near their ear has committed a violation of that law.

Dear Mayor HUGHES:

New Jersey municipalities are affected by the fastest growing criminal enterprise in the world – Human Trafficking.

President Barack Obama and Governor Chris Christie have declared January 11 as National Human Trafficking Awareness Day. Following the lead of our country and the State of New Jersey, on behalf of Benedictine Academy and the NJ Coalition Against Human Trafficking, made up of 70 diverse organizations, we are asking you to join our efforts to combat this terrible crime through a community education campaign by issuing a municipal proclamation designating January 11 as Human Trafficking Awareness Day. This effort will complement New Jersey's recent Human Trafficking Prevention, Protection and Treatment Act passed in to law this past May that has given New Jersey one of the most progressive and comprehensive anti-trafficking statutes in the nation.

A form of modern day slavery, Human Trafficking is the recruitment, harboring, transportation, or obtaining a person through force, fraud or coercion for involuntary labor or services. This crime includes the abduction of persons under 18 years of age for sex trafficking.

Very often large sporting events, such as the Super Bowl, are associated with an increase in Human Trafficking. Such popular events also provide us with opportunities to educate great numbers of the public about the tragic effects of human trafficking. Your proclamation, your local awareness programs, and your support will help deter and diminish the despicable crime of Human Trafficking.

The NJ Coalition Against Human Trafficking offers local programming assistance and expert training programs. Please take advantage of them, and provide us with the name, email address and phone number of your office's point person so they can send you updates and learn of your plans.

November 13, 2013

RE: League Past President Asks All to Join the Fight Against Human Trafficking

Dear Mayor:

Mayor J. Christian Bollwage of Elizabeth, a Past President of your New Jersey League of Municipalities, has asked us to ask you to put your municipality on-record on the issue of human trafficking.

Human traffickers – modern day slave traders - prey on those most in need of society's protection – the young, the poor, the innocent, the weak and the marginalized. Their victims are systematically separated from their families and other support structures. They are transported across local, state and national borders. They are, then, casually rented out to willing buyers and subjected to sexual and labor exploitation.

The first step to combatting this heinous violation of basic human rights and human dignity is to increase general awareness of what it is and how it works. Toward that end, Mayor Bollwage has issued a proclamation, declaring January 11, 2014 as "Human Trafficking Awareness Day" in the City of Elizabeth.

In May of this year, Governor Christie signed AJR-55. Sponsored by Assembly Members Vainieri, Huttel, Stender, Wagner, Quijano, Angelini, Lampitt, McKeon, Wimberley and Mosquero and State Senators Buono, Cunningham, Beck, Gordon, Greenstein, Allen, Vitale, Gill, Madden and Pou, the Resolution had been unanimously passed by both House. It marks January 11 of every year "Human Trafficking Awareness Day" in the State.

In order to promote ongoing education about the signs and consequences of human trafficking, to recognize and advance efforts to end human trafficking in all of its forms, and to encourage support for the victims of human trafficking throughout the State of New Jersey and across the world, we encourage all Mayors to join the City of Elizabeth and the State of New Jersey in this observance.
