Re: Countywide Roadway Resurfacing Program

Dear Mr. Rohal,

Please be advised that the County is planning to resurface the following road under the Countywide Roadway Resurfacing Program this year:

#### Bloomfield Avenue from Broadway, Newark to Passaic Avenue, West Caldwell.

By copy of this letter we are advising your Municipality to complete any improvements or upgrades planned for their systems impacted by this roadway program on or before the project starts.

As you are aware, the County of Essex has a five-year moratorium on County roads resurfaced and/or reconstructed from date of completion of the work. Utility companies will be allowed to work on these County Roads only in case of emergencies, and will be responsible for resurfacing the entire width of the roadway to the satisfaction of the County Engineer.

Your agency will be notified of the pre-construction meeting before construction begins, at that meeting detailed schedule of construction will be discussed, however we emphasize that your agency undertake all necessary repairs as soon as possible to minimize any delays.

Please make sure all responsible personnel within your agency schedule all repair work they need to schedule. All repairs must be completed prior to our milling and resurfacing. Essex County moratorium policy on these roads will be strictly enforced thereafter.
