

A Regular Meeting of The Mayor And Borough Council of The Borough Of Glen Ridge was held on Monday, May 23rd, 2011 in the Council Chamber of The Municipal Building, Glen Ridge, New Jersey at 7:30 p m.

Mayor Hughes led The Council and the citizens in attendance in a Salute to the Flag.

Mayor Hughes read a prepared statement that adequate notice of this meeting had been provided to the public as required by statutes.

Municipal Clerk Rohal presented the following written communications:

A letter from the residents of Tuxedo Road, Midland Avenue and Clark Street, requesting permission to close their respective streets on June 18th, June 18th and June 12th for the purpose of conducting their annual neighborhood block parties. Mayor Hughes referred the correspondence to the Public Safety Committee.

Police Chief Byron - Lagatutta encouraged all block party hosts to notify the Police Department of their block party so that the police can position police cars to block their streets and to assist in any way possible for a successful and fun block party event.
